Privacy Policy

This Privacy Policy ("Policy") applies to www.indyinstitute.com, and Indiana Institute of Excellence ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.indyinstitute.com. The Company's website is a Education site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -First and last name
- -Mailing address
- -Email address
- -Phone number

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

Automatically Collected Information

The Company may automatically collect information about your computer hardware and software. Use of Cookies

The Company's website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
